MEMBERSHIP REQUIREMENTS

All Members must meet all of the requirements to be eligible for membership.

- i) **All Members of the Council must be members of CREA.**
- ii) **For individual members who belong to a local or provincial Board or Association that has a commercial council/committee/division, they must belong to that council/committee/division in order to qualify for and maintain membership in the Council.**

All full members of pre-approved commercial councils/committees/divisions will automatically receive full membership in the Canadian Commercial Council of REALTORS®.

Candidate members of the pre-approved commercial councils/committees/divisions will automatically receive Candidate membership in the Canadian Commercial Council of REALTORS® (candidacy expiry date would be the same as it is locally).

iii) **An individual member of CREA may apply directly for membership in the Canadian Commercial Council of REALTORS® if he or she:**

- a) Belongs to a Board/Association with no pre-approved commercial council/committee/division;

AND

- b) Has specialized knowledge in one or more areas of commercial real estate, namely; appraisal, office leasing, industrial leasing/sales, multi-family/apartment buildings, property management, land/development sites, syndication, investment, retail leasing/business brokerage, consulting, farms/ranches, hotels/motels;

AND

- c) Qualifies for membership under one of the following five options:

OPTION 1: Has provided evidence that he/she has completed at least a basic commercial real estate course, which has been approved by the Council.

In order to be approved the course should cover off the following components:

- Leasing
- Investment Analysis
- Commercial Financial Calculator
- Commercial Construction
- Business Brokerage
- Taxation/Financing
- Planning and Zoning

Examples of acceptable courses include:

- CCIM courses
- UBC Sauder School of Business commercial real estate courses
- A commercial course that is approved by a Canadian real estate licensing regulator

AND has met the following experience criteria:

SALES/LEASING: Has within the last two years completed a minimum of three (3) commercial transactions or a volume of two million dollars (\$2,000,000).

OR

PROPERTY MANAGEMENT: Must have five million dollars (\$5,000,000) of real estate under management.

OR

APPRAISAL: Must have a minimum of six (6) appraisals of industrial, commercial and/or income producing properties within immediate past year, exceeding the value of two hundred and fifty thousand dollars (\$250,000) each and having a minimum aggregate value of two million dollars (\$2,000,000).

OR

A combination of the above

OPTION 2: Has within the last five (5) years completed twenty-five (25) commercial transactions or a minimum of ten million dollars (\$10,000,000) in volume or can demonstrate the equivalent via relevant work experience.

OPTION 3: Holds one of the following pre-approved designations:

- AACI – Accredited Appraiser Canadian Institute
- ALC - Accredited Land Consultant
- CCIM - Certified Commercial Investment Member
- CLO – Certified Leasing Officer
- CLS – Certified Leasing Specialist
- CPM - Certified Property Manager
- CRE - Councilor of Real Estate
- CSM - Certified Shopping Centre Manager
- SIOR – Specialist, Industrial and Office Real Estate
- RI – Designation of the Real Estate Institute of BC

OPTION 4: Can demonstrate significant practical commercial experience over a period of at least ten (10) years as a commercial practitioner.

OPTION 5: **Candidate Membership** - (Candidates must be members of CREA)

An individual who does not meet full membership requirements may apply to become a Candidate Member. Candidate Members will be eligible to become a full Canadian Commercial Council of REALTORS® member upon achieving the **educational qualifications and the transaction/volume qualifications. Education and transaction/volume requirements** must be completed within **three (3) years** of applying as a candidate (*see Option 1*).

Candidate members are **NOT** allowed to advertise their membership in the Canadian Commercial Council of REALTORS® nor are they permitted to use any logo of the Council.

Candidate members of the pre-approved commercial councils/committees/divisions will automatically receive Candidate membership in the Canadian Commercial Council REALTORS®.
